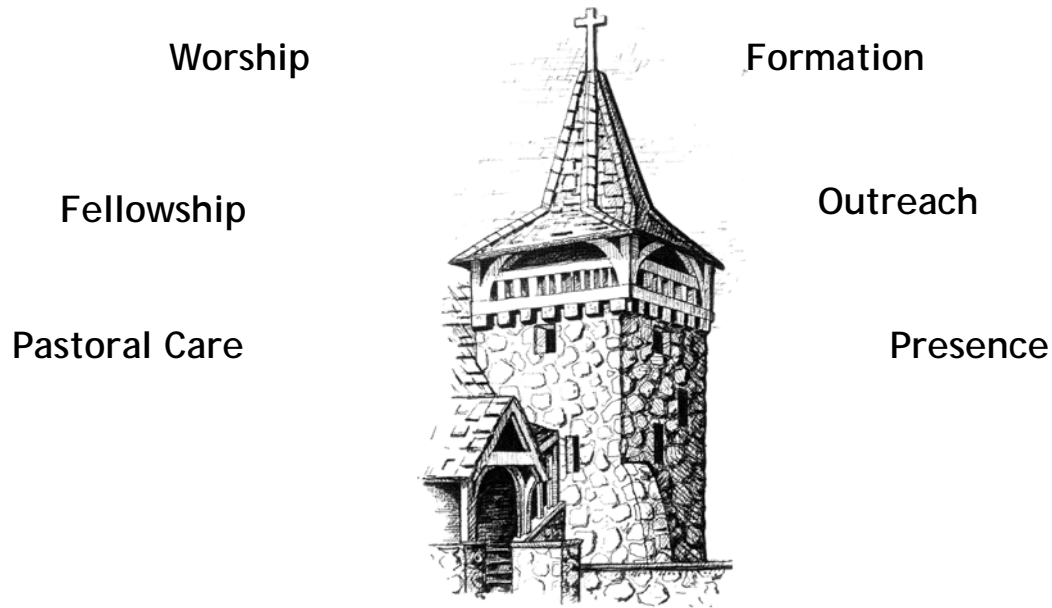

The Minutes of the Annual Parish Meeting 1/26/2020

Opening prayer

The meeting opened at 11:15 a.m. with a prayer by Fr. Michael Bamberger.

Appointment of a clerk

Carol Rasmussen was appointed clerk.

Minutes of the 2019 meeting

Raymond Smith moved that the Minutes of the 2019 meeting be accepted as written. Diane Rhodus seconded the motion. The motion carried.

Nomination and election of vestry members

Four candidates have been nominated to serve on the vestry: Matt Gorman, Dan Hanson, Connie Keith, and Brian Williams. Ted Calleton moved that nominations be closed and candidates be elected by acclamation. Diane Rhodus seconded the motion. The motion carried, and the candidates were elected.

Election of the president of the corporation

Ted Bosley moved to elect Fr. Bamberger as president of the corporation. The motion was seconded by Lisa Wagner and carried unanimously.

Senior warden's report

Senior Warden Gordon Tomaske reviewed the highlights of his written report. The church has completed the Perry project and initiated a roof replacement project with a committee consisting of Scott Callihan, Ray Smith, Fr. Bamberger, Ted Bosley, Mike Beach, and Gordon Tomaske. The committee has received four bids to replace the roof with three bids in the range of \$120-140,000. We anticipate the work will be done this summer. The new roof material looks like slate and is durable and able to resist high winds. The committee is looking for an installer who has experience with this product. Fundraising has begun.

Among other events of the year, Gordon noted that Fr. Roger Wood's house (which he willed to the church) has been rented. At Halloween, the showing of John Carpenter's movie *The Fog*, which used the church as a location, was well attended. Gordon thanked outgoing vestry members Natalie Dougall and Dan Hanson (who is eligible for reelection because of serving a short term).

Rector's report

In the Rector's report, Fr. Bamberger thanked Gordon Tomaske and previous Senior Wardens who were attending the meeting, including John Buchanan, Ted Bosley, Ted Calleton, Jean Rowe, and Rob Stockly. He also thanked the other retiring vestry members and the staff, noting that the long tenures of several staff members are a sign of the parish's stability. Dr. Deborah Huffman now has the longest tenure of any musician at this parish, and Deacon Ed Sniecienski has served for nine years. Fr. Bamberger also thanked Josh and Jobi McGuffie, Diocesan Discerner Tim Hamlin, the altar guild, the acolytes, and all who support the congregation.

Ted Bosley moved to accept the Parish Ministry Reports as printed. Lisa Wagner seconded the motion. The motion carried.

Treasurer's report

Dan Hanson summarized a few salient points from the Treasurer's written report. The church ended 2019 in a better financial state than had been expected when the budget was written, and the 2020 budget looks better than 2019. The Wood house required a larger initial outlay of money than expected to be made rentable, but it is now producing income. Church investments did well. The Investment Committee realigned dividends to free up cash for expenses like the new roof.

Ted Calleton moved to accept the Treasurer's report. Ray Smith seconded the motion, and the motion passed.

Other business

In other business, Fr. Bamberger thanked the auditors, Gordon Tomaske and Hal Ryerson. He announced that John Buchanan has agreed to serve as Senior Warden and asked for volunteers to participate in the 2020 diocesan convention to be held Nov. 13-14 in Riverside. The vestry appoints the delegates, but it's traditional to ask for volunteers at the annual meeting. Maggie Outhouse, Diane Rhodus, and Lynne Holl volunteered.

Fr. Bamberger gave a final thank-you to Nicole Hanson, Fellowship Chair, for organizing the potluck brunch.

Prayer and adjournment

Diane Rhodus moved to adjourn the meeting. The motion was seconded by Liz Levie and passed. The meeting closed with a blessing by Josh McGuffie at 11:39 a.m.

Blessing of the Animals

The Blessing of the Animals was able to happen via a very small, distanced outdoor service. No food or drinks were served.

Thanksgiving Luncheon for the Women's Room at Friends In Deed

We were still able to hold our annual Thanksgiving Luncheon for guests at The Women's Room; but due to social distancing requirements, TWR was only able to host about 10-15 women. We provided a smaller, but still robust meal for the guests with enough leftovers for them to take a container with them when they left. Elizabeth Callihan and some of her friends organized gift bags for the women that included some practical items like warm socks and blankets, as well as some personal/gift items like nail polish and lotion. The bags also included festive treats and notes of encouragement.

Fundraisers

Treasurer's Report

2020 was an interesting year to be a Treasurer...

Your Vestry adopted a budget last January with a published operating deficit of \$30,321.00 and, after weathering more than nine months of pandemic induced disruption to operations and income, closed the books with an actual operating deficit of \$4,983.66. This dramatic reversal of fortune is primarily the result of a federal PPP (Paycheck Protection Program) convertible loan in the amount of \$40,907 that was received in May. I am pleased to report that the loan was forgiven in full in December. This funding was of particular importance in light of the understandable fact that income from giving (pledged and plate offerings) was ultimately \$17,590.91 less than budgeted, giving the Vestry the breathing room to avoid difficult discussions about payroll and expenses.

At year's end, plate offerings totaled \$34,694 versus a budgeted \$26,500 (+\$8,194), while pledge payments came at \$195,215.09 versus a budgeted \$221,000 (-\$25,784.91), totaling to \$229,909.09 versus a budgeted \$247,500 resulting in the \$17,590.91 budgetary shortfall referenced in the paragraph above.

Unsurprisingly, due to the impact of the pandemic, Holy Days Offerings were \$1,285 off of budget (\$4,215 vs \$5,500 budgeted) and the church received no income from filming (\$700 budgeted). Facilities operating expenses came in slightly over budget due to higher than anticipated repair and maintenance costs (\$11,638 vs a budgeted \$8776). However, facilities usage income hit its target for use as a polling place thanks to 2020 being an election year (\$7,755 versus a budgeted \$7,500).

The Wood House is leased at a rate of \$2500 monthly, resulting in a top line gross income of \$30,000 annually. Property taxes paid on The Wood House amounted to \$11,916.73 in 2020. Additional expenses included: \$5,819.40 for repair and maintenance, \$3,034.03 in utilities costs, \$1,125 in property management fees, and \$825 in other miscellaneous other expenses. After taxes and expenses, the church netted \$7,279.84.

The Church of The Ascension's Merrill Lynch account ended the year with a value of \$476,341.49. The sum of interest/dividend income and unrealized gains in value, less fees, resulted in a sum of \$47,876.70 in investment income across the church's portfolio.
